

MINUTES

SELECTMEN'S MEETING

OCTOBER 13, 2005

A regular meeting of the Board of Selectmen was called to order at 11 a.m. by First Selectman, Kevin J. Kopetz. Also present were Albert W. Cretella, III and Janet M. McCarty.

Mr. Cretella moved approval of the minutes of the regular Selectmen's Meeting of September 8, 2005. Voted: Kopetz-yes, Cretella-yes, McCarty-yes

Mr. Kopetz announced the resignation of Giulie A. DeAngelo, 87 Upper State Street, from the Greater New Haven Transit District, Board of Directors, as an Alternate and thanked her for her years of service.

Town Attorney, Jeffrey M. Donofrio, recommended that the Board authorize the issuance of a Request For Proposal (RFP), to attract one party to purchase the surplus material and equipment, as one unit, from the former high school, arrange for their disposal and offer the items for sale to the public at an auction. School Superintendent, Sara-Jane R. Querfeld, explained that all hardware, furniture and equipment that could be used in the school system have been distributed to other schools. This process would relieve the Building Committee of the costs associated with removal and disposal of the items, as well as providing some revenue through the liquidation sale. All revenue will return to the Town's general fund. Mr. Cretella moved to recommend the authorization of an RFP, as per the recommendation of the Building Committee. In response to recent articles in the New Haven Register, the First Selectman thanked Bureau Chief, Ann DeMatteo, for her attention to the hardships of the Fortier family. The North Haven community is reaching out with offers of housing, home repairs and other assistance. In response to a question from the Board, Mr. Kopetz and Mrs. Querfeld confirmed that the high school "Open House" and dedication would be held on October 20th.
